Please read this consent form carefully in its entirety before participating in Misfit Farm & Sanctuary Picture Day. By signing below, you acknowledge that you have read, understood, and agree to all terms and conditions outlined herein.

1. LIABILITY DISCLAIMER

Misfit Farm & Sanctuary, Inc. and its staff, owners, agents, and representatives assume no responsibility or liability for any injuries, illnesses, allergic reactions, or diseases that may occur as a result of proximity to, contact with, or interaction with animals on the premises. Participation in Picture Day is entirely voluntary, and all participants assume full responsibility for their own health and safety while on the property.

Participants or their legal guardians acknowledge and accept that working farms and animal sanctuaries carry inherent risks, including but not limited to animal-related injuries, exposure to allergens, and contact with farm environments.

2. SAFETY & HEALTH GUIDELINES

The safety and health of all participants, staff, and animals is our highest priority. All participants agree to comply with the following guidelines throughout the duration of the event:

- **Supervision:** All participants must remain with the designated photographer at all times. Do not wander into restricted areas or animal enclosures without express permission from farm staff.
- **Hand Hygiene:** Thorough and frequent handwashing is strongly encouraged, particularly before eating or drinking and after any contact with animals or farm surfaces. Hand sanitizer stations are available on-site.
- **Follow Staff Instructions:** All directions given by Misfit Farm & Sanctuary staff must be followed promptly for the safety of all participants.
- **Personal Health:** Participants who feel unwell, experience allergic reactions, or sustain any injury should notify a staff member immediately.

3. ANIMAL CONDUCT & PROTECTION POLICY

Misfit Farm & Sanctuary is committed to the rescue, rehabilitation, and well-being of all animals on the property. All participants must conduct themselves in a respectful and compassionate manner toward the animals at all times.

It is strictly prohibited and unlawful for any person, in any manner, to tease, annoy, disturb, molest, or irritate any of the animals at Misfit Farm & Sanctuary. Any participant found engaging in such behavior will be immediately removed from the premises. Violations may be subject to applicable local, state, or federal animal welfare laws.

4. PHOTOGRAPHY & MEDIA CONSENT

By signing this form, you grant Misfit Farm & Sanctuary, Inc. and its authorized representatives irrevocable, royalty-free permission to use photographs and/or videos taken during Picture Day for promotional and marketing purposes, including but not limited to social media accounts, website, print materials, and other public-facing communications.

You acknowledge that you will not receive compensation for the use of such images or recordings, and you waive any right to inspect or approve the finished product prior to publication.
