SAFETY BRIEFING ACKNOWLEDGMENT

Prior to the start of any event, all vendors and their visitors must receive and acknowledge a safety briefing conducted by Misfit Farm & Sanctuary staff. By signing this form, you confirm that you have been informed of the following:

- **Farm Hazards** — You have been made aware of potential dangers present on the farm, including but not limited to: farm equipment, livestock, uneven terrain, agricultural chemicals, and other site-specific hazards.
- **Proper Handwashing** — You have been instructed on proper handwashing procedures, including washing hands thoroughly before eating, after handling animals, and after contact with soil or farm surfaces. Handwashing stations are available on-site.
- **Emergency Procedures** — You have been informed of emergency exit routes and the process for contacting Misfit Farm management in the event of a safety concern or emergency.
- **Personal Protective Practices** — You understand the importance of wearing appropriate footwear and attire while on farm property.

DESIGNATED AREAS & HEAD COUNT POLICY

All vendors and their visitors are required to remain within the designated areas of the farm that have been pre-approved and discussed with Misfit Farm ownership or staff prior to the start of the event. Unauthorized access to other areas of the property is strictly prohibited.

A mandatory head count of all vendors and visitors must be conducted **before the event begins** and **after the event concludes**. It is the vendor's responsibility to ensure all members of their party are accounted for at both counts.

TERMS, CONDITIONS & LIABILITY WAIVER

- **Evacuation & Event Termination:** Misfit Farm reserves the right to stop any event and require immediate evacuation of all vendors and visitors at any time, at its sole discretion, without prior notice.
- **Event Cancellation:** Misfit Farm reserves the right to cancel any scheduled event at any time. Misfit Farm shall not be held liable for any losses, costs, or damages incurred as a result of such cancellation.
- **Vendor & Visitor Safety Responsibility:** Misfit Farm is not responsible for the safety, health, or well-being of vendors, vendor employees, or their visitors during any event. Each vendor is solely responsible for ensuring the safety and conduct of themselves and all members of their party.
- **Assumption of Risk:** By signing this form, the vendor acknowledges that participation in farm events carries inherent risks, including exposure to animals, farm equipment, uneven ground, and other agricultural hazards. The vendor voluntarily assumes all such risks on behalf of themselves and their visitors.
- **Release of Liability:** The vendor, on behalf of themselves and all members of their party, agrees to release, discharge, and hold harmless Misfit Farm & Sanctuary, Inc., its owners, employees, and agents from any and all claims, damages, losses, or expenses arising from participation in events on the farm property, except in cases of gross negligence or willful misconduct.
- **Compliance with Farm Rules:** All vendors and visitors agree to follow all posted signs, verbal instructions from staff, and any rules communicated during the pre-event safety briefing.
